- 5. Yearly review by the school staff, teachers and parents/guardians to see if there has been improvement in students' skills. Changes may be made to the program, if needed.

How is progress measured?

The school will measure progress by considering student work, student grades, assessment test scores, attendance rates, graduation rates, and dropout rates.
